the receipt whereof is hereby acknowledged, does hereby grant unto said DUKE POWER COMPANY, its
successors and assigns, the right, privilege, and easement to go in and upon that certain tract or lot of land
situated in said County and State, bounded by lands of

South: S. C. Road No. 1316

East: F. B. Barnette

West: Roy Batson, Bleachery Road

and to construct, maintain and operate in, upon and through said premises, in a proper manner, with poles,
wires and other necessary apparatus and appliances, a line for transmitting power by electricity, and for
telephone purposes, together with the right at all times to enter said premises for the purpose of in-
specting said line and making necessary repairs and alterations thereon, together with right at all times
to cut away and keep clear of said line all trees and other obstructions that may, in any way, endanger
the proper maintenance and operation of the same; also including the right to relocate said line over said
premises to conform to any future highway relocation; widening or improvement. It is further
agreed that the company shall relocate its property to conform with
future development of Grantor's lands lying along S. C. Road 1316 for
which this instrument is being obtained. It is understood that the
company shall bear cost of said relocations.
