REAL PROPERTY AGREEMENT

In consideration of such loans and indebtedness as shall be made by or become due to THE CITIZENS AND SOUTHERN NATIONAL BANK OF SOUTH CAROLINA. (hereinsifter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; and
- 3. Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise. and howsoever for or on account of that certain real property situated in the County of

State of South Carolina, described as follows: All the tertain piece, parcel or lot of 1 nd situate lying and being in the St te and county forsaid, dight and fownship near Lenonh school district f 13-L lying Jest from the Gap Creek Ro d and on the South side of the road that le ds from Lenoth School to Mount in Veiw School, being bounded on the North by the 1 st a med road on the East by other lands of myself (G.A. Sindlin) on the South by 1 ands of C.O. brown and on the set by lands of Johnson, having the following courses and distances to witt: BEGINALING on a iron sin in the South edge of the said road joint corner of the Johnson land and runs thence with the Johnson line S 18-00 E, 781 feet to a iron sin on the said lineand joint corner of the C.S. Brown line thence with the C.S. - 4. That if defaul: be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid unpaid to Bank to be due and payable forthwith.
- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.

Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is kereby authorized to rely thereon.
