

2. Effective as of the date title vested in the condemning authority, the rent for the current term of said lease, as provided for in Paragraph 1 of the Agreement dated April 1, 1957, aforementioned, shall be Two Hundred Ninety Five Dollars and Forty Six Cents (\$295.46) per month.

3. Effective as of the date title vested in the condemning authority, the purchase option set forth in Paragraph 6(a) of the lease, as modified by Paragraph 3 of Agreement dated April 1, 1957, and as further modified by Paragraph 4 of Agreement dated October 28, 1960, both agreements being referred to hereinabove, shall be Forty Thousand Six Hundred Seventeen Dollars and Seventy Six Cents (\$40,617.76) during the current term of said lease.

4. Except as hereinabove modified, the parties hereto do hereby ratify and confirm all terms, provisions, conditions and options as contained in said lease and said modifications thereto.
