Smith, Surveyor, August 14, 1964, to wit: BEGINNING at center of Ware Road L. Eden corner, thence along Eden line N. 08-16 E. 400 feet to nail in center of of a treated road, thence along W. C. Burns line S. 54-31 E. 286.6 feet to Davis corner, thence along Davis line S. 29-15 W. 323 feet to point in center of Ware Road, thence along Center of Ware Road N. 68-43 W. 144.8 feet to beginning corner. Bounded on the North by William C. Burns, on the East by William P. Davis, on the South by Ware road and on the West by L. Edens.
