KNOW ALL MEN BY THESE PRESENTS That we, W.E. Eades, W.G. Gosnell
and Litmon H. Huff, as Trustees of the Church of God of Prophecy
of Greer, South Carolina,
 in the State aforesaid, in consideration of the sum of One dollar and the premises
 _____ Dollars

to us in hand paid at and before the sealing of these presents
 by J.R. Jordan, W.O. Reid and H.E. Pigg, as Trustees of the Mountain
View Church of God of Prophecy of Route #2, Campbello, S.C.,
 (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by
 these presents do grant bargain, sell and release unto the said J.R. Jordan, W.O. Reid
and H.E. Pigg, as Trustees of the Mountain View Church of God of
Prophecy of Route #2, Campobello, South Carolina, their Successors and
Assigns forever:

all that piece, parcel or lot of land in _____ Township, Greenville
 County, State of South Carolina, located about two miles south of Gowensville,
 lying on the west side of the Goodjoin Road, having the following courses
 and distances:

BEGINNING at an iron pin in the center of the Goodjion Road,
 and runs thence along the center of said road, N. 34-05 W. 330 feet
 to a stake in the intersection of the Goodjion Road and the Wingo
 Road; thence along the center of the Wingo Road, S. 19-30 W. 373 feet,
 more or less, to a stake, corner of Lot conveyed by the Trustees of
 the Church to Nancy Earline Solesbee; thence with her line, S. 55-22
 E. 130.4 feet to a stake; thence N. 53-05 E. 256 feet to the beginning
 corner, containing 1.50 acres, more or less.

This is all of that tract of land conveyed to J.Y. Sloan, et al.,
 as Trustees, by E. Inman, Master, by deed recorded in Volume 644, page
 127, R.M.C. Office for Greenville County, EXCEPTING the lot heretofore
 conveyed to Nancy Earline Solesbee by deed recorded in Volume 710,
 page 489, in said R.M.C. Office.

On February 6, 1960, E. Inman, Master of Greenville County, con-
 veyed the above described property to persons described as Trustees
 of the Church of God of Prophecy of Greer, S.C., The intention of
 the deed was to convey the property to Trustees on behalf of a group
 which were in process of organizing a Church of God of Prophecy to
 be located at Route #2 Campobello, S.C. (See deed recorded in Volume
 644, page 127, R.M.C. Office for Greenville County.) The designation
 of the location of the Church "of Greer, South Carolina," was in
 error. It was never intended that the property should be conveyed to
 the Church of God of Prophecy located at Greer, S.C. The Trustees
 of the Greer Church are executing this deed for the purpose of quit-
 claiming any right, title or interest the Greer Church may have
 therein and for the purpose of perfecting the title in the true owners.
