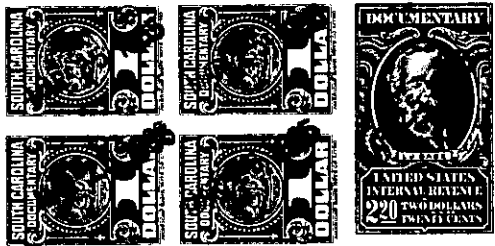

KNOW ALL MEN BY THESE PRESENTS, that WILLIAMS LAND COMPANY, INC.
A Corporation chartered under the laws of the State of SOUTH CAROLINA, and having a principal place of business at GREENVILLE, State of SOUTH CAROLINA, in consideration of Fifteen Hundred Twenty Five and 50/100-----(\$1525.50)-----Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto GIBBS & WILLIAMS, INC., ITS SUCCESSORS AND ASSIGNS, FOREVER:

ALL that certain piece, parcel or lot of land situate, lying and being on the southern side of E. Lee Road, being known and designated as Lot #48 of a subdivision known as Colonial Hills, according to a plat prepared by Piedmont Engineers & Architects, dated April 24, 1964, and recorded in the R. M. C. Office for Greenville County in Plat Book FFF, at Page 102, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of E. Lee Road, joint front corner of lots #48 and #49, running thence along the joint line of these lots, S. 9-00 E. 150.0 feet to an iron pin at the joint rear corner of said lots; thence S. 81-00 W. 100.0 feet; to an iron pin at the joint rear corner of lots #48 and #47; running thence along the joint line of these lots, N. 9-00 W. 150.0 feet to an iron pin on the southern side of E. Lee Road; thence along the southern side of E. Lee Road, N. 81-00 E. 100.0 feet to an iron pin, point of beginning.
