Pace, Mrs. Cora Lee Pace and Benjamin Berdon Pace Lot No. 122-U of Springwood Cemetery, having the following dimensions, to-wit: North 10 feet, East 14 feet, South 10 feet and West 14 feet for the right of burial and cemetery purposes, and to be used exclusively for the right and purpose aforesaid, and subject to the conditions of the Charter of said grantor, and all revisions thereof and amendments may be made thereto, and also subject to the Ordinances of said City and the rules, regulations and by-laws of the City Council and Cemetery Committee, now in force, or which may hereafter be passed, relating to said Cemetery and the burial of the dead therein. The grantor further acknowledges receipt of ____NONE___ perpetual upkeep and care of said cemetery lot by the grantor, its successors and assigns.
