in consideration of One (\$1.00) Dollar, and cancellation of mortgage indebtedness below----- Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release George D. Stewart, his heirs and assigns:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in the City of Greenville, on the north side of Woodfin Avenue (formerly McKay Street) and being known and designated as Lot No. 5, on plat of the property of R. J. Williams, made by R. E. Dalton, November, 1924, and recorded in the R.M.C. Office for Greenville County in Plat Book F, at page 263, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Woodfin Avenue, at joint corner of Lots 5 and 6, which point is 444.3 feet west from Augusta Street, and running thence with joint line of Lots 5 and 6, N. 3-46 W. 186.9 feet to an iron pin on S. O. Skelton property; thence with the line of said property, S. 88-47 E. 50.2 feet to an iron pin, joint rear corner of Lots 4 and 5; thence with joint line of Lots 4 and 5, S. 3-46 E. 182.6 feet to an iron pin on Woodfin Avenue; thence with said Woodfin Avenue, S. 86-14 W. 50 feet to the beginning corner.
