

BEGINNING at an iron pin on the western edge of Stone Lake Drive, joint corner of Lots Nos. 50 and 51 on said plat, and runs thence along the common line of said lots N. 80-30 W. 234 feet to an iron pin; thence S. 17-21 W. 135.1 feet to an iron pin, rear corner of Lot No. 52; thence along line of Lot No. 52 and along the center of a drainage easement S. 80-53 E. 278.3 feet to an iron pin on the western edge of Stone Lake Drive; thence along the western edge of said street, following the curve thereof(the chord of which is N. 1-40 W.) 135 feet to the beginning, and being all of that lot conveyed to the grantor by A.M.Stone, et al, by deed recorded in the R.M.C.
