in consideration of the sum of Eight Hundred and 00/100 ----- (\$800.00) ----- DOLLARS, and assumption of the mortgage referred to below; to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

GERALD R. LEE, his heirs and assigns, forever:

ALL that lot of land, with the buildings and improvements thereon; situate on the South side of East Lee Road, near the City of Greenville, in Greenville County, S. C., being shown as Lot 73 and the Eastern one-half of Lot 72 adjacent thereto, of Block "D", on plat of Mayfair Estates, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", Pages 72 and 73, and having according to said plat, the following metes and bounds, to-wit:
