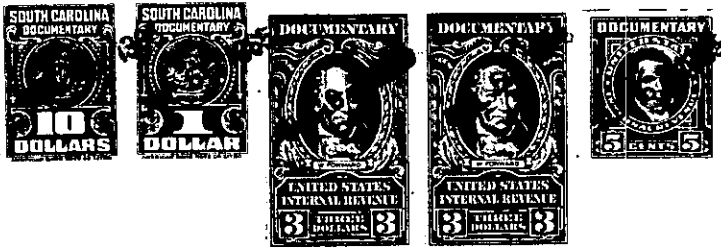
KNOW ALL MEN BY THESE PRESENTS, that Murvell O'Kelly Upshaw
