KNOW ALL MEN BY THESE PRESENTS, That we, JEAN H. KNIGHT and BERT B. KNIGHT, JR.

in the State aforesaid, in consideration of the sum of Five Thousand and No/100 -----
----- (\$5,000.00) ----- Dollars

to us ----- in hand paid at and before the sealing of these presents
by William E. Thompson -----

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said WILLIAM E. THOMPSON, His Heirs and Assigns, Forever:

ALL those lots of land with the improvements thereon situate on the North side of National Highway at Paris Station, in Greenville County, S. C., shown as Lots 2, 3 and 4 on plat of Property of W. D. Parrish made by R. E. Dalton, Engineer, July 1917, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book E, at page 46, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of National Highway at joint front corner of Lots 1 and 2, and running thence with the line of Lot 1, N. 36-43 W. 50 feet to an iron pin; thence with the line of Lot 5, N. 53-40 E. 75 feet to an iron pin on the West side of Mooney Road; thence with the West side of Mooney Road, S. 37-23 E. 50 feet to an iron pin at the Northwest corner of the intersection of Mooney Road and the National Highway; thence along said highway, S. 53-40 W. 75 feet to the beginning corner.

THIS is the same property conveyed to us by deed of W. F. Gosnell, dated March 12, 1952, recorded in the RMC Office for Greenville County, S. C., in Deed Book 452, Page 547. See also deed to us from Charlotte Tripp Holder (Charlotte Tripp Holter) recorded in Deed Book 453, Page 03, R.M.C. Office for Greenville County, S. C.

ALSO, all of those certain pieces, parcels or lots of land at Paris in the County of Greenville, State of South Carolina, being known and designated as Lots Nos. 5 and 6 of the property of W. D. Parrish, as shown on plat thereof made by R. E. Dalton, Engineer, July 1917, and recorded in the RMC Office for Greenville County in Plat Book E, at page 46, said lots having the following metes and bounds according to said plat:

BEGINNING at a stake on the Mooney Road joint corner of Lots Nos. 4 and 5, and running thence S. 53-40 W. 99.5 feet to a point; thence N. 36-43 W. 50 feet to joint corner of Lots 6 and 7; thence along the line of Lot 7 N. 53-40 E. 98.9 feet to the joint corner of Lots 6 and 7; thence along the Mooney Road S. 37-23 E. 50 feet to the beginning corner.
