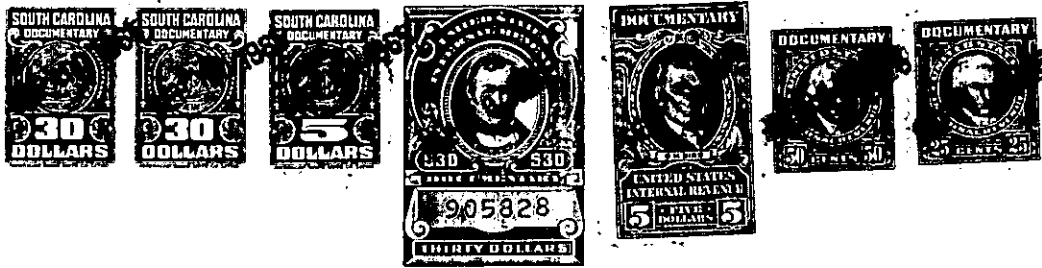
KNOW ALL MEN BY THESE PRESENTS, that I, Beattie E. Huff
