in consideration of FIVE and NO/100 (\$5.00)----- Dollars,

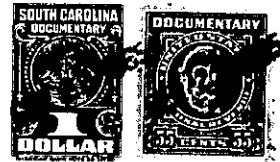
and other valuable consideration (see below)

WHEREAS, J.
