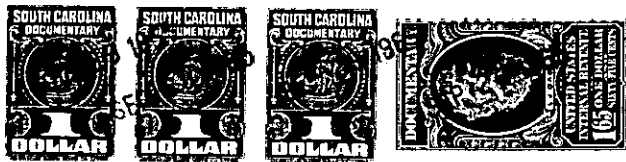
KNOW ALL MEN BY THESE PRESENTS, that We, Florrie E. Greer & William J. Greer
