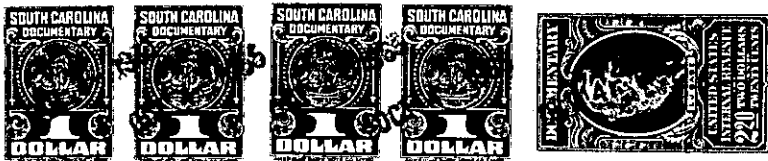
KNOW ALL MEN BY THESE PRESENTS, that I, Bobby R. Satterfield, of Greenville County,

in consideration of Sixteen Hundred Fifty and No/100-----(\$1650.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto  
Lionel O. Vaughn, his heirs and assigns forever:

All that lot of land situate at the northern corner of the intersection of Ashwood Drive and Vine Hill Road in the County of Greenville, State of South Carolina and being shown as Lot No. 214 on a Plat of Pineforest Subdivision prepared by Dalton & Neves dated August 1959, and recorded in Plat Book QQ at Pages 106 and 107 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Ashwood Drive at the joint front corners of Lots 213 and 214 and running thence with the line of Lot 213, N. 28-07 E. 150 feet to an iron pin at the joint rear corner of Lots 216 and 215; thence with the line of Lot 215, S. 61-53 E. 175.1 feet to an iron pin on the northwestern side of Vine Hill Road; thence with the line of Vine Hill Road, S. 37-35 W. 127.1 feet to an iron pin; thence with the curvature of the intersection of Vine Hill Road and Ashwood Drive (the chord being S. 77-51 W. 38 feet) to an iron pin on the northeastern side of Ashwood Drive; thence N. 61-53 W. 125.2 feet to the point of beginning; being the same conveyed to me by Kathleen J. Rodrigue by deed dated August 31, 1965, to be recorded herewith.
