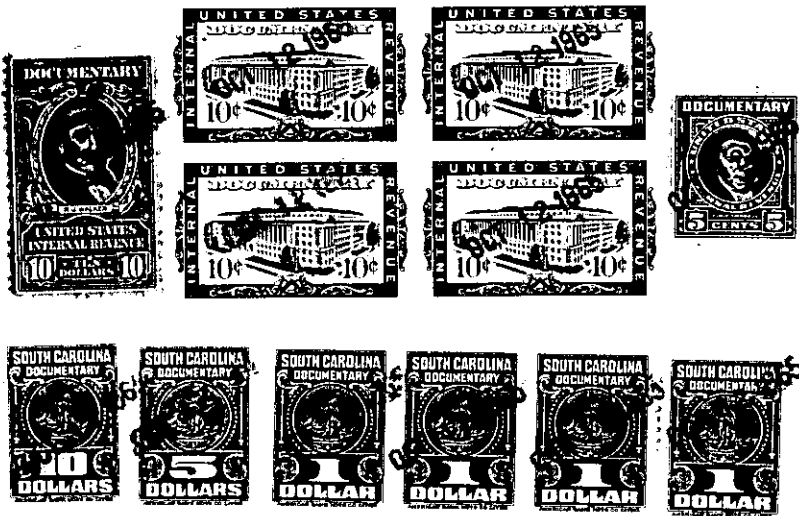
KNOW ALL MEN BY THESE PRESENTS, that I, Jack E. Shaw
