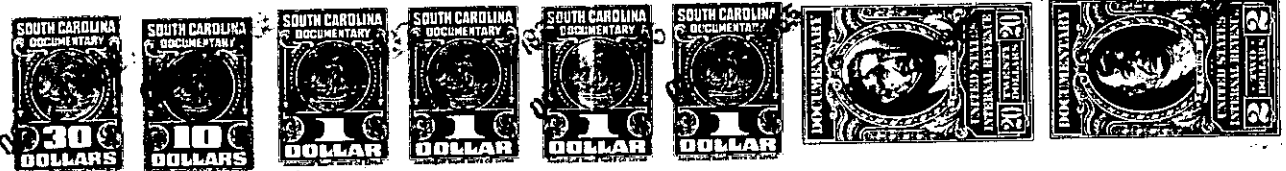
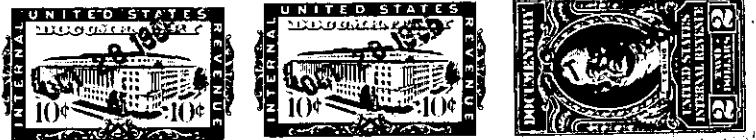
in consideration of Twenty-Two Thousand and No/100 - - - - - Dollars,
