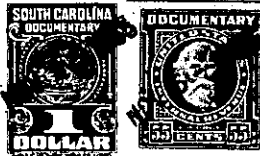

in consideration of Three Hundred and No/100 (\$300.00) - - - - - Dollars
and assumption of mortgage indebtedness set forth below,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto WILLIAM E. HOLCOMBE and FRANCES L. HOLCOMBE, their heirs and assigns
forever,

ALL that lot of land with improvements on the northwestern side of Curtis Road in Greenville County, South Carolina, being shown and designated as a major part of Lot No. 11, and a lot to the rear and adjoining Lot No. 11 on a Plat of the Property of Mrs. Farley H. Jones, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book NN, Page 83, and having according to a more recent Plat thereof entitled "Property of Terry D. Gunther and Virginia H. Gunther", made by C.C. Jones, Engineer, dated February, 1964, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book FFF, Page 27, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Curtis Road at the joint front corners of Lots Nos. 10 and 11, and running thence a new line through Lot No. 11, N. 40-00 W. 239 feet to a point in a branch; thence in a southwesterly direction with said branch as the line; 75 feet, more or less, to a point; thence S. 38-51 E. 44 feet to an iron pin at the joint rear corners of Lots Nos. 11 and 12; thence along the line of Lot No. 12, S. 38-51 E. 192 feet to an iron pin on the northwestern side of Curtis Road; thence along the northwestern side of Curtis Road, N. 56-02 E., 80 feet to an iron pin, the beginning corner.

The above described property is the same conveyed to the grantors by deed of Henry C. Harding recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 743, Page 35.

As a part of the consideration for this deed, the grantees assume and agree to pay in full the indebtedness due on that certain note and mortgage in favor of Cameron-Brown Company covering the above property in the original sum of \$9,200.00 recorded in the R.M.C. Office for Greenville County, South Carolina, in Mortgage Book 950, Page 59, upon which there is a present balance due in the sum of \$ 8,904 49.
