KNOW ALL MEN BY THESE PRESENTS, that EARL GRIFFIN

in consideration of TWO HUNDRED FIFTY AND NO/100-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ALBERTA M. HAGOOD, Her Heirs and Assigns:

ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being shown as the northernmost portion of Lot No. 15, Block A, as shown on a plat of Washington Heights, according to a survey made by N. O. McDowell, Jr., and Julian P. Moore, in December, 1944, which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book "M", at page 107, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the fence post of property now owned by Lena Speach (middle portion of original Lot 15, Block A), which point is 77.1 feet from Washington Loop, and running thence N. 15-24 W. 29.4 feet to the northern boundary of original Lot 15, Block A; thence running in a southwesterly direction approximately N. 72-25 E. 45.6 feet to an iron pin; thence S. 12-45 E. approximately 29.4 feet to an iron pin; thence with the fence of Lena Speach N. 72-25 E. approximately 45.6 feet to front corner fence post of Lena Speach, the point of beginning.

This is the same property described in corrective deed from J. B. Boyd, Lena Speach, Emma Satterwhite and Robert Lee Satterwhite to Earl Griffin dated November 16, 1965.
