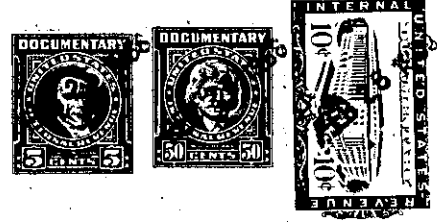

ALL that piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 112 as shown on plat of a subdivision known as Thornwood Acres, Section 2, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "MM" at page 105, and having, according to said plat the following metes and bounds, to-wit;
