

ALL that lot of land with the buildings and improvements thereon situate on the Northwest side of Woodridge Circle, near the Town of Mauldin, in Greenville County, South Carolina being shown as Lot No. 47 on plat of Windsor Park made by R. K. Campbell, Surveyor, March 29, 1960, recorded in the RMC Office for Greenville County, South Carolina in Plat Book RR, Page 25, and having according to said plat the following metes and bounds to wit:

BEGINNING at an iron pin on the Northwest side of Woodridge Circle at the joint front corner of Lots 46 & 47 and runs thence along the line of Lot 46 N. 71-0 W., 155 feet to an iron pin on the Southeast side of Devonshire Road; thence along the Southeast side of Devonshire Road S. 19-0 W., 100 feet to an iron pin; thence along the line of Lot 48 S. 71-0 E., 155 feet to an iron pin on the Northwest side of Woodridge Circle; thence along Woodridge Circle N. 19-0 E., 100 feet to the beginning corner.

Moore conveyed their interest in the above described lot to Pleasant Homes, Inc. by deed recorded in the RMC Office for Greenville County, S. C. on May 5, 1960 in Deed Book 649, Page 410.
