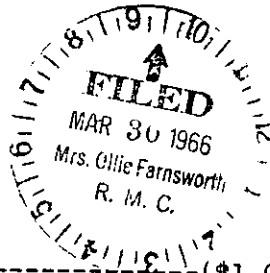

KNOW ALL MEN BY THESE PRESENTS, that I, Vernon Whitmire

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Ray B. Voorhies and Lena R. Voorhies, their heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being a portion of Lots Nos. 133 and 134 of a subdivision known as Camilla Park, Map 2, as shown on a plat thereof being recorded in the R.M.C. Office for Greenville County in Plat Book M, at Page 85, and also being known as a Re-subdivision of Lots Nos. 8, 9, and 10, of the property of Talmer Cordell as shown on a plat prepared by J. Mac Richardson, June 23, 1958, recorded in the R.M.C. Office for Greenville County, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the corner of Lot No. 7 Beatrice Street, approximately 263.5 feet from the intersection of Welcome Avenue and Beatrice Street, and running thence S. 67-48 W. 137.3 feet to an iron pin; thence N. 21-50 W. 60 feet to an iron pin at the rear corner of Lots Nos. 6 and 7 Beatrice Street; thence N. 67-48 E. 157 feet to an iron pin; thence N. 11-02 W. 78.4 feet to an iron pin; thence N. 67-48 E. 278.9 feet to an iron pin; thence S. 21-55 E. 20 feet to the beginning corner.
