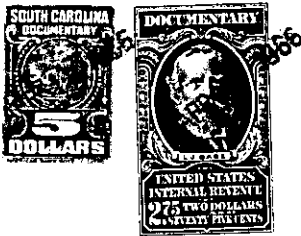
KNOW ALL MEN BY THESE PRESENTS, that I, Mary Gladys Hack Gilstrap
