the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and
release unto **James Lester Dilleshaw, his heirs and assigns forever:**

All that certain piece, parcel or lot of land, situate, lying and being in
the State of South Carolina, County of Greenville, being an unnumbered lot and being
located to the rear of and adjoining Lot 121 as shown on a plat of a revision of
portion of Sections 2 and 3, Lake Forest Subdivision as shown on a plat thereof
being recorded in the R. M. C Office for Greenville County in Plat Book BB at
Page 20, and said unnumbered lot being described according to a plat entitled
"Revision of Lots 119, 120 and 121, Section No. 2 Lake Forest" prepared by
Piedmont Engineers and Architects, dated February 21, 1966, to be recorded
herewith, as follows:

BEGINNING at an iron pin, old joint rear corner of Lots 120 and 121 and
running thence with a new joint line of said lots, S. 86-31 E. 79.6 feet to an iron
pin; thence continuing the same course to a point at the high water mark of Lake
Fairfield; thence along the high water line of Lake Fairfield; the traverse line
of which is S. 1-42 E. 55.5 feet to an iron pin; thence leaving the high water line
of Lake Fairfield as the same intersects with the branch and following the center
of said branch as the line in a southwesterly direction, the traverse line of which
is S. 78-37 W. 63.4 feet to an iron pin; thence leaving the center of said branch
and running N. 14-33 W. approximately 13.8 feet to an iron pin; thence along the
old rear line of Lot 121, N. 14-33 W. 75.3 feet to the beginning corner.

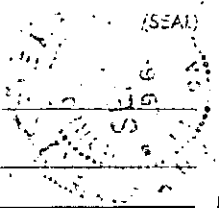
This conveyance is made subject to any restrictions, easements or rights-
