the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto ADGIER MCKINNEY, his heirs and assigns, forever:

ALL that lot of land with improvements lying on the Southern side of Blossom Drive in Gantt Township, Greenville County, South Carolina, being shown as Lot No. 139 on a Plat of Kennedy Park made by Piedmont Engineers and Architects dated September 28, 1964, revised January 28, 1966, recorded in the RMC Office for said County and State in Plat Book JJJ, page 179, and having according to said plat a frontage on the Southern side of Blossom Drive of 75 feet, running back in parallel lines for a depth of 133 feet.

The above described property is hereby conveyed subject to restrictive covenants applicable to Kennedy Park recorded in the RMC Office for said County and State in Deed Book 773, page 527, and to utility rights of way and drainage easements shown on the aforesaid plat and appearing of public record.

As a part of the consideration for this deed, the Grantee assumes and agrees to pay in full the indebtedness due on a note and mortgage covering the above described property in favor of Carolina Federal Savings & Loan Association of Greenville, S. C., recorded in the RMC Office for said County and State in Mortgage Book 1029, page 1, which has a present balance due in the sum of \$9,000.00.

The Grantee agrees to pay 1966 Greenville County property taxes.
