Nellie L. Brown, her heirs and assigns, forever:

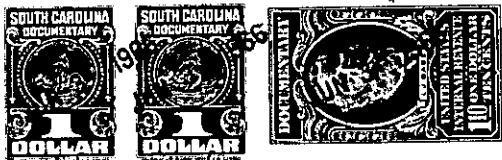

Willis, Engineers, dated November 19, 1960, recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 179, and having according to said Plat, the following description, to-wit:

BEGINNING on Barcelona Street at an iron pin at joint front corners of Lots 41 and 40; and running thence 80 with the line of said Street to an iron pin at joint front corners of lots 40 and 39; running thence 180 feet with the side line of lot 39 to an iron pin at joint rear corners of lots 40, 39, 45 and 44; running thence 80 feet with the rear line of lot 44 to an iron pin at joint rear corners of lots 40, 41, 43 and 44; running thence 180 feet with the side line of lot 41 to the iron pin on Barcelona Drive joint front corners of lots 40 and 41, the point of beginning.

No residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 35 feet to the front line; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only.

THIS conveyance is subject to all easements and rights of way of record.
