release unto Robert W. Neuman and Beverly H. Neuman

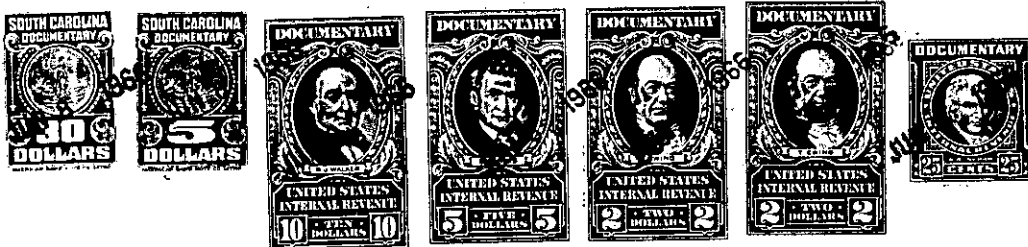
