An undivided one-half interest in and to all that certain piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being on the northeasterly side of Lockwood Avenue, in the City of Greenville, South Carolina, and being shown as Lot No. 86 on the plat of ELLETSON ACRES, Section B, as recorded in the R.M.C. Office for Greenville County in Plat Book "QQ", Page 5, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Lockwood Avenue, joint front corner of Lots 85 and 86, and running thence along the common line of said lots N. 56-06 E. 248.1 feet to an iron pin; thence N. 29-15 W. 80 feet to an iron pin; the joint rear corner of Lots 86 and 87; thence along the common line of said lots S. 60-28 W. 256.4 feet to an iron pin on the northeasterly side of Lockwood Avenue; thence along said avenue S. 27-54 E. 48.4 feet to an iron pin; thence continuing with said avenue S. 42-02 E. 50.4 feet to an iron pin, the point of beginning.

BEGINNING at an iron pin on the easterly side of Lockwood Avenue, joint front corner of Lots 86 and 87, and running thence along the common line of said lots N. 60-28 E. 256.4 feet to an iron pin; thence along a new line through Lot 87 S. 62-49 W. 253.4 feet to an iron pin on the easterly side of Lockwood Avenue; thence along the easterly side of Lockwood Avenue 10.7 feet to an iron pin, the point of beginning.
