in consideration of ONE THOUSAND SEVEN HUNDRED FIFTY AND NO/100---(\$1,750.00)----- Dollars,

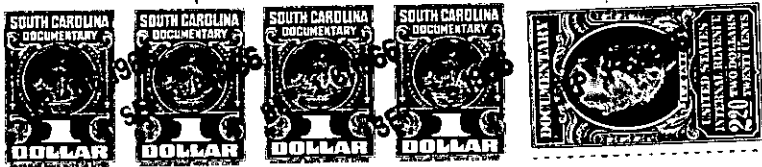
