All that lot of land situate on the northwest side of Pimlico Road in the City of Greenville in Greenville County, South Carolina, being shown as Lot No. 459 on plat of Section D of Gower Estates, made by R. K. Campbell and Webb Surveying and Mapping Co., May 1964, recorded in the RMC Office for Greenville County, S. C., in Plat Book RR, at pages 192 and 193, and having according to said plat the following metes and bounds, to-wit:
