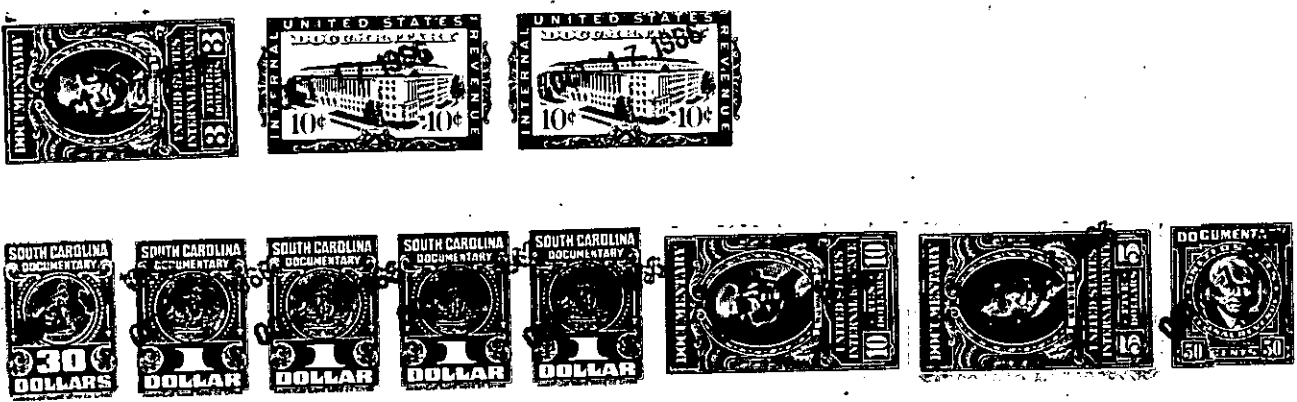

sum of Sixteen Thousand Nine Hundred Fifty and No/100ths (\$16,950.00)----- dollars, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto ALVIN E. TAYLOR and PATSY W. TAYLOR:

All that piece, parcel or lot of land situate, lying and being on the North-eastern side of Theodore Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 4 as shown on a plat of Carolina Heights, prepared by Dalton & Neves, dated August, 1964, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book BBB at page 29; and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Theodore Drive at the joint front corner of Lots Nos. 3 and 4, and running thence with the line of Lot No. 3 N. 32-17 E. 157.13 feet to an iron pin; thence with the line of property now or formerly of Theodore N. 48-52 W. 91.3 feet to an iron pin at the joint rear corner of Lots Nos. 4 and 5; thence with the line of Lot No. 5 S. 41-38 W. 154.7 feet to an iron pin on the Northeastern side of Theodore Drive; thence with the Northeastern side of Theodore Drive S. 48-22 E. 117.2 feet to the point of beginning.
