

All that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being shown and designated as a portion of Lot 11, Block A, as shown on a Map of Augusta Court, recorded in Plat Book F at Page 124, and being more particularly described according to a recent survey prepared by R. E. Dalton, dated February 1954, as follows:

BEGINNING at a stake in the northwestern side of Augusta Court, which point is 500 feet southwest of the intersection of Augusta Court and Augusta Road, and is the joint front corner of Lots 10 and 11, Block A, and running thence with the joint line of said lots N. 37-57 W. 124.3 feet to an iron pin; thence through Lot 11, S. 52-03 W. 116.2 feet to a stake in the eastern side of Augusta Court; thence with the curve of Augusta Court, the chords of which are as follows: S. 50-42 E. 50 feet, S. 73-0 E. 50 feet, N. 84-42 E. 50 feet and N. 64-0 E. 35.7 feet to the point of beginning.
