All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 1 on plat entitled "Property of G. D. Oxner" dated April, 1923 prepared by R. E. Dalton, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book G, at page 42, and having according to recent plat entitled "Property of Byrdie K. Smith" dated November 25, 1966, prepared by Piedmont Engineers & Architects, recorded in Plat Book NNN, at page 4, the following metes and bounds:

Beginning at an iron pin on the southern side of Laurel Street at the joint front corner of Lots Nos. 1 and 2 and running thence S. 33-54 W. 178.5 feet to a point on the northern side of Bates Street (which point is S. 33-54 W. 1.15 feet from an iron pin); thence with the northern side of Bates Street N. 56-06 W. 50.0 feet to an iron pin; thence N. 33-54 E. 178.7 feet to an iron pin on the southern side of Laurel Street; thence with the southern side of Laurel Street S. 55-54 E. 50.0 feet to the point of beginning.
