N. Leslie, Inc., Its Successors and Assigns, Forever:

ALL those lots of land situate on the North side of Forestdale Drive and on the South side of Forestdale Drive in the city of Greenville in Greenville County, South Carolina, being shown as Lot Nos. 31, 32, 37, 38 and 39, on plat of Forestdale Heights, recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, Page 199, and having the following metes and bounds, to-wit:

Lots 31 and 32 being described as follows:

BEGINNING at an iron pin on the South side of Forestdale Drive at the joint front corner of Lots 36 and 37 and runs thence along the line of Lot 36, S 4-31 W 188.06 feet to an iron pin; thence N 85-45 W 210 feet to an iron pin; thence along the line of Lot 40 N 4-31 E 189.16 feet to an iron pin on the South side of Forestdale Trive; thence along Forestdale Trive, S 85-29 E 210 feet to the beginning corner.
