

ALL that lot of land with improvements lying on the Northeastern side of Ponce de Leon Drive in the City of Greenville, Greenville County, South Carolina, being shown as Lot No. 21 on a Plat of part of the Estate of J. T. Blassingame, made by Dalton & Neves, Engineers, dated June, 1937, and recorded in the RMC Office for Greenville County, S. C., in Plat Book J, page 117, and having according to said plat, the following metes and bounds, to wit:
