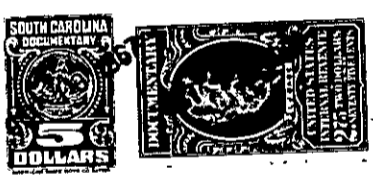
Charles H. Moore, His Heirs and Assigns Forever:
