the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ERNEST C. WOOD, his heirs and assigns, forever:

All of that lot of land in the County of Greenville, State of South Carolina, Bates Township, at Travelers Rest, S. C., known as the northern portion of Lot # 10 on plat of Montevideo, recorded in Plat Book "KK", Page 102, in the R. M. C. Office for Greenville County, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of W.
