KNOW ALL MEN BY THESE PRESENTS, that We, Bobby Joe Hill and Julia R. Hill (formerly Julia A. Roper)

in consideration of One Thousand Five Hundred and No/100-----(\$1,500.00) Dollars, and assumption of mortgage indebtedness listed below the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Howard Franklin Hill, Sr., and Ersie G. Hill, their heirs and assigns, forever:

ALL that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the northwesterly side of Alpine Way, in the City of Greenville, South Carolina, being known' and designated as Lot No. 28 on plat of Property of Central Development Company, as recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book BB, at Pages 22 and 23 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwesterly side of Alpine Way; said pin being the joint front corner of Lots 27 and 28 and running thence with the common line of said Lots N. 50-41 W. 175 feet to an iron pin; thence S. 39-19 W. 75 feet to an iron pin, joint rear corner of Lots 28 and 29; thence with the common line of said Lots S. 50-41 E. 175 feet to an iron pin on the northwesterly side of Alpine Way; thence with the northwesterly side of Alpine Way N. 39-19 E. 75 feet to an iron pin, the point of Beginning.

As part of the consideration herein, the grantees assume and agree to pay that certain note and mortgage in favor of The Prudential Insurance Company of America, which mortgage is recorded in the R. M. C. Office for said County and State in Mortgage Book 967, Page 271, and the balance due on said mortgage is \$15,259.57.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s) or on the premises.
