do grant, bargain, sell and release unto the said J. P. STEVENS & CO., INC.:

ALL that piece, parcel or tract of land containing 36 acres, more or less, situate, lying and being on the Western bank of Enoree River near the Town of Taylors, County of Greenville, State of South Carolina, and having according to a plat prepared by Piedmont Engineers & Architects, dated September 26, 1967, entitled "Property of Katie H. Bolin near Taylors, S. C.," and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book VVV at page 69, the following metes and bounds:
