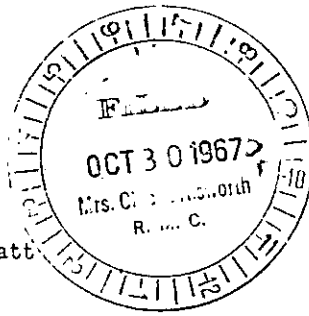

of the State and County aforesaid

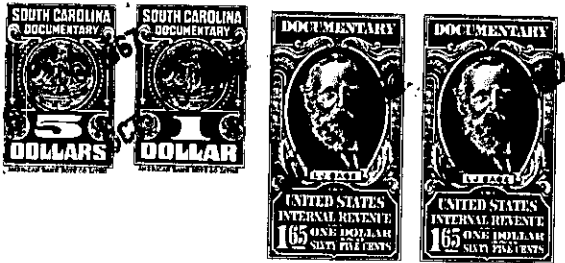
in consideration of Three Thousand and no/100-----(\$3000.00)-----Dollars,

Norwood Cleveland and R. Mays Cleveland Estate on August 6, 1943. Recorded in Book 255, Page 269, R.M.C. Office for Greenville County and having the following metes and bounds, to-wit:
