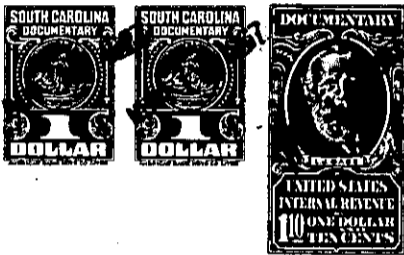
in consideration of Eight Hundred and No/100 (\$800.00)----- Dollars,
