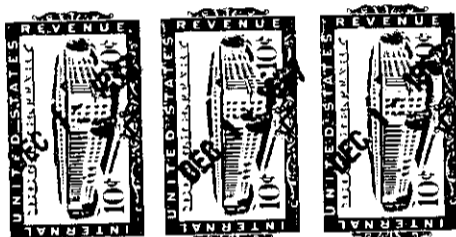
KNOW ALL MEN BY THESE PRESENTS, that I, O. B. Godfrey
