

This Deed made the 23rd day of June, 1967 between SOUTHERN HOLDING CORP., a Georgia corporation, with its principal offices at 1424 Healy Building, Atlanta, Georgia, and HOME SECURITY CORPORATION, a Florida corporation, with its principal offices at 6701 North Broad Street, Philadelphia, Pennsylvania.

WITNESSETH, That in consideration of Five Hundred Dollars (\$500) and other valuable consideration in hand paid, the receipt whereof is hereby acknowledged, the said grantor does hereby release, remiss, remit and quitclaim unto HOME SECURITY CORPORATION, its heirs, executors and assigns forever, the following described property situated in the Township of Dunklin, near Princeton, County of Greenville, and State of South Carolina, to-wit:
