the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto
WILLIAM C. LIVINGSTON AND MARY ALICE LIVINGSTON, their heirs and assigns:

ALL that certain piece, parcel or lot of land situate, lying and being in Grove Township, Greenville County, South Carolina, designated as Lot Number 4 on a plat of Section No. 2 of Belle Terre Acres, prepared by C. O. Riddle, R. L. S., July 1964, and revised October 1965, the same containing 2.14 acres, more or less, and having the following courses and distances, to-wit:

BEGINNING at a point in the center of S. C. Highway Number 106 at the joint front corner of Lots Numbers 4 and 5, and running thence along the line of Lot Number 5 S. 20-34 E. 377.5 feet to an iron pin; thence S. 76-48 E. 290.1 feet to an iron pin; thence along the line of Lot Number 3 N. 7-40 E. 384.2 feet to the center of said highway; thence along the center of said highway N. 81-41 W. 101 feet to a point; thence still along said highway N. 76-31 W. 103.8 feet to the point of beginning.
