All that certain parcel or lot of land situated about two miles eastward from Sandy Flat, O'Neal Township, Greenville County, State of South Carolina, and being Lot No. 25 of BLUE RIDGE HEIGHTS according to survey and plat by John A. Simmons, Registered Surveyor, dated October 15, 1960, recorded in Plat Book "EEE", at page 69, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:
