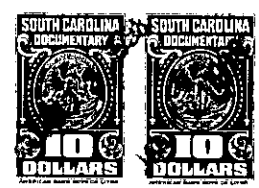
DILLARD HOWARD, HIS HEIRS AND ASSIGNS, FOREVER:
