ALL that certain tract of land located in Greenville County, State of South Carolina, and in Paris Mt. Township, having a frontage of 447.8 feet along S. C. Highway #250 (By-Pass), containing 3.3 acres according to a plat of the PROPERTY OF W. GLENN HAWKINS made by Robert Jordan, Engineer, September 16, 1967, and recorded in the RMC Office for Greenville County in Plat Book VVV, Page 61, and having according to said plat the following courses and distances, to-wit:

BEGINNING at an iron pin on the right-of-way of S. C. Highway #250 (By-Pass) and running thence N. 77-06 E. 412.6 feet to an iron pin; and running thence N. 66-05 E. 222.7 feet to an iron pin; and running thence N. 10-45 W. 220.8 feet to an iron pin; and running thence S. 84-39 W. 312 feet to an iron pin on the right-of-way of S. C. Highway #250 (By-Pass), and running thence S. 34-21 W. 447.8 feet to the point of beginning.
