ALL my right, title and undivided interest in and to: ALL that certain piece, parcel or lot of land on the east side of Fourth Street, in Section No. 2 of Judson Mills Village, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 26 as shown on plat of Section 2 of Judson Mills Village, made by Dalton & Neves, Engineers, in November 1939, which plat is recorded in the R. This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s) or on the premises.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
