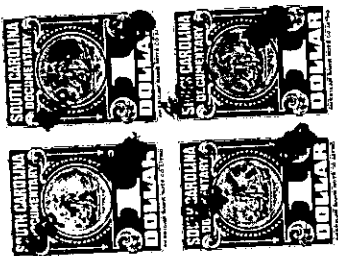
KNOW ALL MEN BY THESE PRESENTS, that -----Lanco, Inc.-----
A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of --One Thousand, Seven Hundred, ---Ninety-five and No/100 (\$1,795.00)----- Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto ---Eddie Jones, Jr., his heirs and assigns:

All that piece, parcel or lot of land lying and being situate on the westerly side of French Lane near the City of Greenville in the County of Greenville, South Carolina being known and designated as Lot No. 120 according to plat of Pine Hill Village, a subdivision, prepared by R. K. Campbell, R.L.S. dated July 9, 1962 as recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book QQ at Page 169, the following metes and bounds to wit:

BEGINNING at an iron pin on the westerly side of French Lane at joint front corner of Lots 119 and 120 and running thence along the joint line of the said lots S. 72-56 W. 155 feet to an iron pin at joint rear corner of the said lots in drainage easement; thence through the said drainage easement along the rear lines of Lots 123 and 124 S. 28-17 E. 78.6 feet to an iron pin at joint rear corner of Lots 120 and 121; thence along the joint line of the said lots N. 74-38 E. 137.7 feet to an iron pin at joint front corner of the said lots on the westerly side of French Lane; thence along said French Lane N. 17-04 W. 74.5 feet to an iron pin at joint front corner of Lots 119 and 120, the point of beginning.
